Community Connectors and Turnaround Project

Community Youth Connectors – referrals from schools

The Youth Justice Service is delivering a new early intervention and prevention project. Community Connectors will work with girls, on a 1:1 consent based approach. They will act as a conduit between services, offering support to children to access initial sessions through empowerment and awareness.

They will identify the individual needs of the children through developing relationships with the child and adults known to the child. This approach will enable a holistic approach to support and empower the child and their family with the aim of breaking down barriers and increasing engagement with education, mental health support and the community offer. Our Connectors will also work with girls to reconnect them with their educational setting and support them to overcome barriers that may prevent this.

Eligibility for the project is as follows;







- young girls aged 8 15 years who;
- have difficulties with their mental health such as low levels of low mood and anxiety
- have poor school attendance as a result of poor wellbeing
- have difficulties with their relationships in school/home or/and the community
- are on the cusp of offending or displaying anti-social behaviour

Turnaround Project – referrals from our in house YOS police.

Ministry of Justice prevention initiative at Sefton Youth Justice, The Turnaround Programme. This programme is to support children and their families when a child has committed a criminal offence or anti-social behaviour at an early stage without them entering the criminal justice system. The child does not have to admit guilt but must be willing to engage and consent is also required from the child's parents /carers. Our role is to support children and their families. In order to do this, an allocated worker will work with children and families to deliver services based on their needs to prevent any further offending or risk taking behaviour.

Criteria;

The child has received one of the following: 10-17 yrs old

- Interviewed under caution following arrest or subject to a criminal investigation attending a voluntary interview
- Subject to No Further Action (NFA) decisions
- Subject to a Community Resolution
- First-time youth caution, not including conditional caution;
- Released under investigation (RUI) or subject to pre-charge bail (PCB)
- Discharged by a court; acquitted at court; and/or fined by a court
- In receipt of Community Protection Orders (CPO), Civil Orders and/ or Acceptable Behaviour Contracts (ABCs) for anti-social behaviour.
- Referral received within three months of the above
- Not received Turnaround support previously
- Not open to Early Help (England) and receiving whole family support co-ordinated by a lead practitioner
- Open as a CIN with a clear unmet need, that Turnaround can meet as part of a co-ordinated plan
- Not previously on YOT statutory caseload

Thrive Network Sefton & Youth Voice Update

Thrive Network – meeting took place on 13 June, work continues for the Task & Finish Group looking at PE and how it can be more inclusive to improve mental health. Chris Debar from Active Sefton is leading on this piece of work supported by Georgia Ribbens and Sharon Cotterall. We recently had a meeting with Emma Hart from Inclusion to look at how we can work together on this.

The CWAN (Children with Additional Needs Network) is no longer in operation. The Thrive Network have agreed to have a standing item for SEND updates on the agenda. Member of CWAN have been contacted re this.

Sefton Youth Voice Strategic Steering Group - continues to grow membership with good representation from across the partnership now. We have set up an action tracker to keep up to date with progress. We have just developed a Survey Monkey with Young Advisors to support the Early Help Partnership in their review of Early Help in Sefton. VOLA - Digital Connectivity for Community Facilities Grants ProgrammeStuart McGrory

Round 2 now open

Round 2 of <u>VOLA</u>'s UKSPF *Digital Connectivity for Community Facilities* Grants Programme is now open for applications, from Monday 19th June 2023. Applications of between £2,500 and £10,000 are welcomed. The application deadline is 5pm, Monday 17th July 2023.

All documents relating to the application process will be available on <u>VOLA's website</u> from 5pm on Monday 19th June. These include:

- Application form
- Application guidance
- FAQs
- Link to online map of local digital community facilities so you can see what's already in your area
- Supporting, ward-level data on digital exclusion and deprivation which will help you to understand local need and enable you to assert this in your application
- Slides and recordings from recent online briefing sessions

Interested applicants that were unable to attend the briefing sessions are strongly urged to look through the slides and watch the recordings before applying. Doing so will massively boost your chances of success! In Round 1, organisations that attended the briefing sessions generally submitted better quality applications than those that didn't and were more successful in receiving funding, with less ineligible costs removed from their proposed budgets.

In particular, the 'technical hints and tips' briefing gives some real food for thought and - as the title says - provides a wealth of extremely useful hints and tips to consider when setting up a community-access computer facility. Follow this advice and you will be able to set up a fit-for-purpose digital facility that will last a long time, reduce ongoing running costs (and IT headaches!) and ensure you cover your legal duty of care requirements.

Background to the fund

Funded through the Government's <u>UK Shared Prosperity Fund</u> (UKSPF), through the <u>Liverpool City Region</u> <u>Combined Authority</u> as the local Lead Authority, the fund support the creation of new, and improvement of existing community facilities where people can go to access computers and get online.

The overall purpose of the grants programme is to support voluntary, community, faith and social enterprise (VCFSE) sector organisations to improve their public-facing IT (i.e. computer drop-in) facilities, and to create new facilities in areas of need, where there may currently be no, or limited provision.

The aim of the grants programme is to provide funding and support to:

- 1. Target neighbourhoods where there is currently a lack of community-based digital facilities to help local, VCFSE organisations to set up new computer drop-in facilities
- Upgrade outdated and poor-quality digital kit and/or improve broadband connectivity in community facilities, where current equipment &/or connections can be evidenced as being poor
- 3. Increase capacity, by providing funding to purchase more digital devices, where current facilities are insufficient to meet demand.







Please note: the fund is <u>not</u> about improving organisations' general IT infrastructure (i.e. it is not for kitting your staff/ volunteers out with new computers), and grants <u>cannot</u> be used to fund technical equipment that is purely aimed at recreational activities, or the direct delivery of digital skills training, other activities, or organisational overheads. **It is purely aimed at funding the 'kit and connectivity'.**
